



Institutions registered under section 932 do not require further authorization from the Ministry of Education. Section 932 is divided into two subsections:

932.1 is for Non Higher Education

932.2 is for Higher Education

3. En caso de cancelación por parte de un beneficiario, el coordinador del curso deberá contactar directamente con el suplente de la lista de reserva. Por ello es recomendable que los coordinadores confeccionen listas de titulares y suplentes, de acuerdo con las solicitudes recibidas.

BIU FORMAL RECOGNITION FROM OTHER UNIVERSITIES





OF SCIENTIFIC AND EDUCATIONAL COLLABORATION**
between
SAINT-PETERSBURG UNIVERSITY OF TECHNOLOGY AND DESIGN (Russia)
and
Bircham International University

1. Subject and Terms of Agreement

- 1.1. The subject of the present agreement is to establish cooperation in the sphere of development of academic and scientific mobility of the students, teachers and non-teaching staff of the two institutions.
- 1.2. The present agreement is concluded with the aim of a mutual international cooperation in the sphere of science and education.
- 1.3. The present agreement is concluded for a period of 5 years and can be extended by mutual consent of the two institutions.
- 1.4. The present agreement is not to be considered as a contract in law creating legal and financial relationships between the two institutions. Detailing every further particular type of cooperation, as well as the terms and the order of financial settlements arising from within the framework of this agreement are to be determined by addenda to the present agreement being an integral part thereof.
- 1.5. The present agreement is made up of two copies, in Russian and English languages, both being equally valid.

2. Types and Forms of Cooperation

- 2.1. Teachers and non-teaching staff:
 - teaching activity;
 - conducting joint scientific research and publications;
 - coordination of educational programmes;
 - acquiring additional professional training;
 - further professional development, etc.
- 2.2. Students and post-graduate students:
 - Student exchange on an equal basis;
 - Teaching students according to coordinated educational programmes, including the possibility of conferring diplomas of both institutions;
 - Conducting joint scientific research and publications;
 - Installing production and scientific practices and probations;
 - Training post-graduate students according the programmes of joint scientific guidance, etc.

3. The terms of fulfillment and secession from the Agreement

- 3.1. Each institution undertakes to further contribute and develop in all possible way in its own institution the kinds and forms of cooperation envisaged by this agreement.
- 3.2. Each institution undertakes, in sending their teachers, students and non-teachers on exchange trips, to maintain their status (post), rights and responsibilities in accordance with the statutes of the respective institution.
- 3.3. Unless otherwise is specified all expenses arising from the exchange trips of the teachers, students and non-teachers within the framework of the present agreement are to be referred to the institution or the person concerned.
- 3.4. Within the framework of this agreement each institution is considered as independent partner and is not authorized to act in the name of the other institution and is not responsible for actions of its partner.
- 3.5. Each institution has the right to secede from the partnership based on the present agreement by notifying thereof its partner not later than 30 days before the actual secession. In case of a teacher, a

post-graduate student or a non-teacher being on an exchange trip according to the terms of the agreement or according to the terms of the addenda to this agreement while one of the partners seceding from the agreement, the realization and the completion of the initiated projects are to be stipulated additionally.
